#### **Dissertation Abstract**

# Praise, Pride, and Dignity: Black and Indigenous Struggles for Social Justice

This dissertation investigates the social practices and political arrangements that embody the positive attitudes of praise and pride. Chapter one argues that admiration, as a public form of praise, can disrupt a community's relations of equal accountability by elevating the admired person to a position of moral superiority —what I call *the pedestal problem*. Chapter two argues that admiration, far from being a spontaneous individual emotion, is an expression of deep-rooted social values and may thereby serve as a mechanism for reinforcing the narratives that sustain oppressive systems. As a case study, I analyze the controversy surrounding the two statues of Spanish *conquistadores* that were removed by the Misak Indigenous community, in the context of the 2021 Colombian national strike. Chapter three develops an *agonistic model* of pride focused on cases where pride is experienced as *opposition* to insults rather than an *endorsement* of approbation, as proposed by a widely accepted *celebratory model* of pride. This chapter takes as a central case study the Afro-Colombian movement led by Francia Márquez Mina.
